The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".

The Albanian Mine Action Executive monitored and coordinated the Mine Risk Education activities, which again for 2008 were conducted by the local NGO-Victims of Mines and Arms, Kukësi Association (VMA) and the Albanian Red Cross (ARC). Both these organizations had their accreditation renewed in early 2008 by the Albanian Mine Action Executive upon submission of all required documentation.

The main aim of the Mine Risk Education activities was to keep 25,500 mine affected community members in the 22 still contaminated villages (as of the beginning of 2008) informed about the mine & UXO threat. As a result of progress in mine clearance operations, the number of mine/UXO affected villages in 2009 is reduced to 16. It is worth mentioning that there were no mine incidents recorded in northeast Albania during 2008.

The Victims of Mines and Weapons Association-VMA implemented an MRE Project funded by the US State Department through the International Trust Fund of Slovenia with a total value of 79,800 USD.

Under this project and in cooperation with the village anti-mine committees, regular monthly gatherings were organized with the communities and leaflets with information on the mine risk and the safe behavior were disseminated. Other activities carried out were the MRE mobile theatre performances. The mobile theatre with comedians travels regularly from village to village to disseminate safety messages through comedies and parodies. MRE materials were provided to the mine affected communities on a regular basis

including posters and leaflets. School based activities related to MRE were organized and consisted of: competitions among classes for the best poster, leaflet, song, role plays and information about mine fields, mine risk signs and environment issues.

Furthermore a new leaflet was published by the Albanian Red Cross (ARC) in consultation with AMAE, which contains messages promoting a safe behavior with mines and unexploded ammunition. The leaflet was distributed by ARC volunteers in ammunition hotspot areas of 10 prefectures in Albania.

Some 1300 books for pupils in schools near the Kosova border with awareness messages on the danger of mines were also distributed by the Albanian Red Cross.

Mine Victim Assistance

The Victim Assistance component covered a wide range of support to the mine survivors during 2008 including: emergency assistance and ongoing healthcare, physical rehabilitation and provision of prostheses, social and psychological support and socio-economic reintegration. These activities were monitored and coordinated by AMAE and carried out in cooperation with various implementing partners including the Ministry of Health, Kukës Regional Hospital, Directorates of Public Health in Kukes, Has and Tropoja, the National Prosthetic Orthotic Center (NPOC) in Tirana, ICRC-Swiss Fund for Disabled (SFD), Victims of Mines and Arms (VMA), the International Trust Fund in Slovenia, Handicap International and the Slovenian Institute for Rehabilitation.

> Access to Physical & Medical Rehabilitation in Albania-Phase II

The project aims to help public authorities develop and implement a consistent and long-term plan to ensure access to physical and medical rehabilitation services to the entire Albanian population while implementing measures responding to the immediate needs of landmine victims. The second phase of this project covers the period 2008 -2010 and again is funded by US DoS and implemented by Handicap International. During the year 2008 the following activities were carried out under this project:

- 6 technicians, respectively from Kukes, Tirana and Pogradec, continue the training in above knee modules and upper limbs. This training is planned to be completed by March 2010.
- Technical support in building the prosthetic capacities has been provided to the two technicians of the Prosthetic Workshop in Kukes Regional Hospital.
- Under the technical assistance from Handicap International 12 new prostheses were produced in Kukes and at least 120 repairs were done during 2008 for the mine survivors and other local amputees in need.

• 25 additional students were registered in the academic year 2008-2009 in the Physiotherapy Branch at the Faculty of Nursing in Tirana supported by this Project.

Physical Rehabilitation of amputees in Slovenia

This project is designed to assist upper limb amputees and other difficult cases that can not be assisted in Albania with prostheses and physical rehabilitation. The project is implemented by Institute of Rehabilitation of Slovenia (IRSS) and funded by US DoS. In 2008, the following activities took place under this project:

- With AMAE coordination, a triage of 45 people injured mainly in the ammunition hotspots throughout Albania, was conducted in Tirana at the National Prosthetic- Orthotic Centre by medical specialists from the Slovenian Institute of Rehabilitation. As a result, 19 amputees have been already rehabilitated with prostheses for the period September December 2008 at the Institute of Rehabilitation of Slovenia.
- Another 9 amputees are in process of rehabilitation for the period January- May 2009.

> Improving the physical rehabilitation capabilities of Kukes Regional Hospital

A Prostheses Workshop has been established in Kukes Regional Hospital since 2005 with UNDP/DFID support. The Ministry of Health in order to strengthen the capacities of the Workshop provided a larger space within the main building of the hospital and also contributed to its rehabilitation. However, the Prostheses Workshop lacked funding for the raw materials and supplies needed to make and repair prostheses and therefore requested support from UNDP. A list of raw materials and supplies was finalized in cooperation with the Regional Health Authorities and were procured through AMAE/UNDP with funding from DFID under the "Support to MA Programme" Project.

The materials and components provided under this project are being used to assist landmine survivors and other people with disabilities in improving their mobility and access to the physical environment, and thus improving their quality of life.

> Improving the capacities for survivors assistance

ICRC-SFD continued its support to the National Prosthetic Orthotic Center (NPOC) through the provision of raw materials for prosthesis. Another key aspect of this project is the improvement of management capacities and capabilities of the current staff of the Center through technical support visits and assistance by ICRC-SFD.

> Support to Social-economic reintegration of mine survivors in Northeast Albania

The project aims to strengthen a revolving loan fund that has already provided interest free loans to 63 mine survivors in northeast Albania during previous years. It will support 25 mine/ERW survivors in establishing home based economies and seek to link the fund to appropriate micro-finance structure at the regional level and to ensure that the fund provides equal opportunities to all survivors. This project is funded by US DoS and implemented by the local NGO-VMA.

During 2008 the following activities were carried out under this project:

- Commodities (cows) have been procured and distributed to 22 selected beneficiaries.
- 3 more beneficiaries have established the inseminations units in their respective zones.
- All 22 beneficiaries have paid the due amount for the first year to the revolving loan fund.
- All beneficiaries from the previous years have paid back the loan during 2008.

➤ Support to Socio-economic reintegration of mine/ERW survivors

This Project is funded by SIDA and implemented by UNDP through the local NGO -VMA. The main objectives of this project are to: increase employment/ business opportunities of mine/ERW survivors of Kukes Region by improving their professional/ entrepreneurship skills; increase their access to medical and rehabilitation support services by providing logistic support and improve their social-integration by providing direct outreach psycho-social and peer support services (outreach and counseling services). The Project started in September 2008 and by the end of the year the following activities were carried out:

• 25 beneficiaries (15 survivors and 10 family members-adults) attended vocational training courses in the following specialties:

•	Electro-domestic repairs	- 8 persons
•	Computer basic course	- 4 persons
•	Auto-electrician course	-5 persons
•	Industrial electronics course	- 1 person
•	Hydro-sanitary installations	- 3 persons
•	Radio-TV repair course	- 1 person

- 2 mine survivors were hired and trained on the methodology and techniques of peer support survivors.
- 79 survivors were assisted and medicated at home by the VMA Nurse.
- 87 survivors' families were visited by the Peer Support Team of VMA.
- 52 mine/ERW survivors received psycho social support provided by the Social Worker of the targeted communes.
- 120 leaflets with information on prosthesis maintenance were produced and distributed.

➤ "Night of a 1000 Dinners" – Beneficiary Event

The Night of a Thousand Dinners is a world-wide Mine Action charity event to help solve the global landmine crisis. Albania has held so far 4 events of "Nights of A Thousand Dinners" in the following years: 2003, 2005, 2006, and the most recent one in October 2007, were individual donors as well as Governmental Authorities, local private businesses, the diplomatic community and NGO-s. Over \$19, 000 were donated at this latter event. This donation was matched by US DoS/ITF and has been used for mine victim assistance in Albania to assist 10 young mine survivors to continue their elementary and secondary studies, as well as with vocational professional trainings.
