#### Form I Measures to provide warning to the population

- Article 7.1 "Each State Party shall report to the Secretary-General ... on:
  - i) The measures taken to provide an immediate and effective warning to the population in relation to all areas identified under paragraph 2 of Article 5."

Remark: In accordance with Article 5, para.2: "Each State Party shall make every effort to identify all areas under its jurisdiction or control in which anti-personnel mines are known or suspected to be emplaced and shall ensure as soon as possible that all anti-personnel mines in mined areas under its jurisdiction or control are perimeter-marked, monitored and protected by fencing or other means, to ensure the effective exclusion of civilians, until all anti-personnel mines contained therein have been destroyed. The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".

The Albanian Mine Action Executive monitored and coordinated the Mine Risk Education (MRE) activities, which again for 2009 were conducted by the NGO- Albanian Assistance for Integration and Development - ALB-AID (former VMA) and the Albanian Red Cross (ARC). Both organizations had their accreditation renewed in early 2009 by the Albanian Mine Action Executive upon submission of all required documentation.

The main aim of the Mine Risk Education activities was to keep 16,500 mine affected community members in the 16 contaminated villages informed about the mine & UXO threat. It is worth mentioning that there were no mine incidents recorded in northeast Albania during 2009.

The NGO ALB -AID implemented an MRE Project funded by the US State Department through the International Trust Fund of Slovenia up to July 2009. Under this project and in cooperation with the village anti-mine committees, regular monthly gatherings were organized with the communities and leaflets with information on the mine risk and the safe behavior were disseminated. Other activities carried out were the MRE mobile theatre performances. The mobile theatre with comedians travels regularly from village to village to disseminate safety messages through comedies and parodies. MRE materials were provided to the mine affected communities on a regular basis including posters and leaflets. School based activities related to MRE were organized and consisted of: competitions among classes for the best poster, leaflet, song, role plays and information about mine fields, mine risk signs and environment issues.

The Albanian Red Cross (ARC) implemented a data collection project in 10 prefectures in Albania promoting a safe behavior to the areas affected with unexploded ammunition. A new leaflet was published by ARC in consultation with AMAE, which contains messages for the safe behavior, which was distributed by ARC volunteers in ammunition hotspot areas of 10 prefectures in Albania. In addition, ARC participated actively in the handover ceremonies of cleared land in Northeast Albania.

During 2009 UNICEF Albania funded a project to Institute of Curriculas for the preparation of two updated MRE/ERW/SALW manuals in order to continue to introduce Risk Education into compulsory public school curriculum in cooperation with the Ministry of Education and Science (MoES).

#### **Mine Victim Assistance 2009**

The Victim Assistance component covered a wide range of support to the mine survivors during 2009 including: emergency assistance and ongoing healthcare, physical rehabilitation and provision of prostheses, social and psychological support and socio-economic reintegration. These activities were monitored and coordinated by AMAE and carried out in cooperation with various implementing partners including the Ministry of Health, Ministry of Education, Kukës Regional Hospital, Directorates of Public Health in Kukes, Has and Tropoja, the National Prosthetic Orthotic Center (NPOC) in Tirana, ICRC-Special Fund for Disabled (SFD), the NGO "Albanian Association for Assistance, Integration and Development" ALB-AID (previously known as VMA), the International Trust Fund (ITF) Slovenia, Handicap International and the University Rehabilitation Institute Republic of Slovenia.

#### > Access to Physical & Medical Rehabilitation in Albania-Phase II

The project aims to help public authorities develop and implement a consistent and long-term plan to ensure access to physical and medical rehabilitation services to the entire Albanian population while implementing measures responding to the immediate needs of landmine victims. The second phase of this project covers the period 2008 – May 2010 and again is funded by US DoS and implemented by Handicap International. During the year 2009 the following activities were carried out under this project:

- 25 physiotherapists were graduated for the first time in Albania at the Faculty of Nursing in Tirana by June 2009.
- A Physiotherapy cabinet is established at the Faculty of Nursing in Tirana and will be used for training/teaching purposes.
- 6 technicians, respectively from Kukes, Tirana and Pogradec, continue the training in above knee modules and upper limbs. This training is planned to be completed by March 2010.

- Technical support in building the prosthetic capacities has been provided to the two technicians of the Prosthetic Workshop in Kukes Regional Hospital.
- Through technical assistance from Handicap International, 21 new prostheses were produced in Kukes and at least 68 major repairs were done during 2009 for the mine survivors and other local amputees in need.
- 25 additional students were registered in the academic year 2009-2010 in the Physiotherapy Branch at the Faculty of Nursing in Tirana.

# > Medical equipment and training support to Kukes Regional Hospital

This project is designed to assist Kukes Regional Hospital to improve the emergency and ongoing health care capacities. Kukes Regional Hospital provided the main support to the people injured in mine/UXO incidents. The project is funded by US Department of State and the main activities in 2009 include:

- Donation and installation of the Electro-surgical unit in the Surgical Department of Kukes Hospital. Training for the use of the equipment was also provided to the relevant personnel.
- Donation and installation of the Radiography & Fluoroscopy X- Ray TV system (Axiom ICONOS R100) in Kukes Hospital.
   Training for the use of the equipment was provided to the medical personnel.
- During May-June 2009, five (5) Kukes Regional Hospital specialists (three from the rehabilitation unit and two from the hospital management) participated to a training organized at the University Rehabilitation Institute, Republic of Slovenia.

# > Improving the capacities for survivors assistance

ICRC-SFD continued its support to the National Prosthetic Orthotic Center (NPOC) through the provision of raw materials for the production of prosthesis/orthoses. Another key aspect of this project is the improvement of management capacities and capabilities of the current staff of the Centre through technical support visits and assistance by ICRC-SFD.

#### Physical Rehabilitation of amputees in Slovenia

This project is designed to assist upper limb amputees and other difficult cases that can not be assisted in Albania with prostheses and physical rehabilitation. The project is implemented by the University Rehabilitation Institute Republic of Slovenia and funded by US Department of State. In 2009, the following activities took place under this project:

- With AMAE coordination, a triage of 60 patients injured mainly by mines and UXOs in northeast Albania, was conducted in Kukes, Has and Tropoja by medical specialists from the University Rehabilitation Institute Republic of Slovenia.
- As a result of the triage 11 mine/UXO amputees have been already rehabilitated with prostheses during September December 2009 at the University Rehabilitation Institute of Slovenia.

#### ➤ Vocational Training & Local Enterprise Initiative for mine/ERW survivors in Kukes region.

This Project is funded by US DoS through ITF and implemented by the NGO ALB-AID. The overall objective of the one year project is to provide access and support for mine survivors and/or their family members from the mine affected communities in northeast Albania to attend vocational and entrepreneurship business training courses. The Project was completed in July 2009 and the following activities were carried out:

# > Socio-economic reintegration initiative for the survivors of Gerdec explosion

The project aims to directly support about 300 survivors or the family members from the explosion of the ammunition depot in Gerdec in 2008, to be re-integrated into the society. The project is funded from the US DoS through ITF and implemented by the NGO ALB-AID and the activities of this project include:

- 49 students completed the English and Computer courses during the period September- December 2009.
- 56 new pupils have started the second shift in English and Computer courses

# ➤ "Night of a Thousand Dinners 2009"

The humanitarian event, "Night of a Thousand Dinners 2009" which was hosted by the US Embassy in Tirana in cooperation with AMAE in November 2009 raised over 12, 218USD from individual donors including the Albanian private sector. These donations were matched by ITF through US State Department and are currently being used to assist 8 young child mine survivors for educational activities.

# > The Tirana Workshop on a Mine-Free South Eastern Europe

A regional event "The Tirana Workshop on a Mine-Free South Eastern Europe" took place from 7 to 9 October 2009 in Tirana with the support of the European Union and the AP Mine Ban Convention ISU. Participants in the workshop included representatives from mine-affected countries in South Eastern Europe, landmine and unexploded ordnance survivors, donors, local, international and non-governmental organizations that have contributed to mine action in the region.

A parallel programme for victims' assistance experts was held as well in the margins of this regional event, with the assistance of the ISU VA experts. The parallel programme highlighted challenges and successes in addressing the rights and needs of mine survivors in the region. The programme included discussions on medical and physical rehabilitation, psychosocial support and economic empowerment of the survivors.
