Mine Victim Assistance 2010

The main focus of the mine action activities during 2010 was on the assistance to the mine/ERW victims. The mine victims assistance covered a wide range of support for 2010 to the mine/ERW survivors and other persons with disabilities in Albania including: emergency assistance and ongoing healthcare, physical rehabilitation and provision of prostheses, social and psychological support and their socio-economic reintegration. These activities were monitored and coordinated by AMAE and carried out in cooperation with various implementing partners including the Ministry of Health, Ministry of Education, Kukës Regional Hospital, Directorates of Public Health in Kukes, Has and Tropoja, ICRC-Special Fund for Disabled (SFD), the NGO "Albanian Association for Assistance Integration and Development" (ALB-AID), the International Trust Fund (ITF) Slovenia, Handicap International and the University Rehabilitation Institute Republic of Slovenia.

> Access to Physical & Medical Rehabilitation (PMR) in Albania

This project aims to help public authorities develop and implement a consistent and long-term plan to ensure access to physical and medical rehabilitation services to the entire Albanian population while implementing measures responding to the immediate needs of landmine victims and other persons with disabilities. The second and third phase of this project was again funded by US DoS and implemented by Handicap International France.

The main activities which were monitored and coordinated by AMAE during the project period include:

- A national strategy for the development of PMR services has been now adopted by the Ministry of Health;
- A Physiotherapy Educational program based on European standards is being implemented by the Nursing Faculty of Tirana.

- 30 students were registered for the academic year 2010-2011.
- A one-year formal training programme for twenty PMR medical doctors from all over Albania was conducted during 2009-2010, at the Faculty of Nursing in Tirana on physical medicine and rehabilitation.
- Technical support in building the prosthetic capacities has been provided to the two technicians of the Prosthetic Workshop in Kukes Regional Hospital. A Rehabilitation unit is now functioning, providing services for local patients including landmine survivors. Under the technical assistance of Handicap International, 17 new prostheses were produced in Kukes and at least 48 major repairs were performed during 2010 for the mine survivors and other local amputees in need. More than 500 patients benefited from the services provided by this PMR unit (including physiotherapy and P&O services);
- Seven Ortho-prosthetic technicians, respectively from Kukes, Tirana and Pogradec, successfully finalized the training in above knee modules and upper limb modules during 2010.

➤ Medical Training for the Albanian Health Professionals

This project was designed to assist health professionals to improve their capacities on medical and physical rehabilitation. The project was funded by US DoS and the main activities coordinated during 2010 included:

Three medical doctors from Mother Teresa University Hospital and the regional Hospital of Durres participated in a series of
training courses in Ljubljana on the subjects of the "KINEZIOTAPING". The Ministry of Health appointed the candidates to
participate at the training and AMAE coordinated with other partners the activity and facilitated the arrangements for the
medical doctors to attend the training. The training courses were organized by a US University for countries of Southeast
Europe and were financed by US DoS through International Trust Fund Slovenia.

> Physical Rehabilitation of amputees in Slovenia

This project assists amputees classified as difficult cases who cannot be assisted in Albania with prostheses and physical rehabilitation. The project is implemented by the University Rehabilitation Institute of Republic of Slovenia and funded by US DoS. 15 mine/UXO amputees were rehabilitated with prostheses during 2010 at the University Rehabilitation Institute of Republic of Slovenia

> Vocational Training and Local Enterprise Initiative for mine/ERW survivors and their family members

The Project was funded by US DoS through ITF and implemented by the Albanian NGO ALB-AID. The aim of the project was to increase economic autonomy of mine survivors and their family members by improving their labor skills and opportunities. This is achieved through various vocational trainings with mine survivors and their family members.

In this regard, a Survey was conducted with all mine/UXO survivors and a database was established with the data collected, based on an already agreed point system, in order to ensure equality and transparency of selection, as well as to prioritize mine/UXO survivors and provide the required support based on their immediate economic needs.

Based on the requests of the survivors and the point system established, those interested were instructed about the courses and supported financially to attend courses in vocational training centers of Prizren, Gjakova and Peja, upon an agreement between the Governments of Albania and Kosovo.

Twenty one individuals being mine/UXO survivors or their family members have attended such courses for a period of 4-6 months and upon successful completion they were issued certificates, which are valid in both countries- Kosova and Albania. In addition, the students were trained on entrepreneurship skills and techniques of employment, job description, CVs, etc.

> Socio-economic reintegration initiative for the survivors of Gerdec explosion

The project aims to directly support the reintegration of the survivors or their family members from the explosion of the ammunition depot in Gerdec, in March 2008. The project was funded by the US DoS through ITF and implemented by the national NGO ALB-AID.

The activities of this project during 2010 included:

- A survey was carried out with families of the victims and the data gathered were entered and processed in the database.
- 56 students completed the English and Computer courses throughout the year. All pupils who participated in the training were supported with used computers, as part of the project.
- Training facilities were identified and furnished with the required training equipment.

• Psycho-social sessions with children at the Community Friendly space and regular recreation/cultural activities were organized on regular basis.

> National Victim Assistance Workshop

On 3-4 November 2010, the Ministry of Health and the Ministry of Defense in collaboration with the Albanian Mine Action Executive (AMAE) organized a National Victim Assistance Workshop, which gathered representatives from different line ministries: Ministry of Health, Ministry of Labor, Social Affairs and Equal Opportunities, Ministry of Defense, regional health authorities and other local authorities, donors of the Albanian Mine Action Programme, organizations and other actors involved in the disability issues in Albania. Additionally, disabled people, landmine and cluster munitions survivors were an active part in discussing the priorities for the future Victim Assistance plans. The main objective of the workshop was to make an analysis of the progress as to date in this area and to develop a long term national plan in line with the Cartagena Action Plan adopted at the Second Review Conference. The workshop was funded by the European Union through the United Nations Development Programme (UNDP) and the International Trust Fund for Demining and Mine Victim Assistance, Slovenia (ITF). Some of the priorities identified for the victim Assistance plan resulting from the workshop include:

- A detailed analysis of the medical and socio-economic reintegration needs of 688 survivors from the abandoned unexploded ordnances (AXO) all over Albania. Priority to be given to areas with highest number of victims such as: Shkodra, Elbasan, Tirana (Gerdec), Vlora, Durres and Kukes.
- Continue the required support and strengthen the existing capacities at the rehabilitation unit at Kukes Regional Hospital.
- Improve management capacities and services provided by the National Prosthetic Center in Tirana. Identification of a proper location of this center was considered as a high priority.
- Make use of the experience gained in northern part of the country to further expand the assistance activities to the areas with considerable number of survivors from the abandoned unexploded ordnances (AXO).
