[Narrative:]

A Higher Committee for Mine Action was established in early 2012 as a PA senior level inter-ministerial body that is currently developing and adapting legislation with regards to mine action. As such, the Higher Committee mandated and allocated resources in February 2012 to the Palestinian Mine Action Center (PMAC) - hosted within the Ministry of Interior in Ramallah to coordinate all mine action related aspects in the West Bank with UNMAS' Technical Advice.

Mine Risk Education and victim assistance form an integral part of the PMAC's mandate in the West Bank. No national MRE programme has taken place in the West Bank in 2011/12; however discussions have taken place whereby UNICEF, James Madison University and other partners have confirmed their interest in supporting the PMAC in develoing comprehensive MRE and victim assistance programs in the West Bank. The PMAC has also established in early July 2012 an MRE/VA position within its core staff.

No specific strategic framework for victim assistance is in place in the oPt at the moment. Mine/ERW survivors receive the same support as other disabled members of the population. This support falls under the responsibility of the Ministry of Health and the Ministry of Social Affairs. OPt legislation provides for the provision of health and social insurance, economic opportunities, and equality for persons with disabilities.

The PMAC intends to work with partners to set up specific referral and medical assistance mechanisms for Mine/ERW survivors; and advice the PA for adapting Palestinian legislation accordingly.
