Location of destruction sites: <b>The minefields in south of Tunisia are mixed, containing anti-personnel and anti-tank mines which are hidden in a sandy ground with formation and disappearance of dunes caused by the wind.</b>	
<b>In accordance with article 5 of the Ottawa convention, Tunisia started the destruction of the anti-personnel and anti-tank mines in the undermines zones, since 25 November 2004. By the end of March 2009, it finished the clearance of all minefields on its soil by removing and destroying all the anti-personnel and anti-tank mines in accordance with its engagement in OTTAWA's convention (before December 2009).</b>	Methods

The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps ant Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have indiscriminate effects".
