#### Form I Measures to provide warning to the population

The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".

Austria provides assistance for mine action through bilateral and multilateral programs and as a Member State of the European Union supports mine action activities of the European Union.

In 2021, Austria provided support over the amount of € 10.000,- to the Implementation Support Unit of the Mine Ban Convention as well as € 7.000 to the International Campaign to Ban Landmines and the Cluster Munitions Coalition (ICBL-CMC) in support of the Landmine/Cluster Munitions Monitor Report for 2021.

In 2021, Austria continued its support to a mine action (mine clearance/MRE) project being implemented since 2019 by ITF in northeast Syria over the amount of  $\in$  3.000.000 for 2021-2022. The Austrian Embassy in Kyiv provided  $\in$  10.000,- to a victim assistance project in Ukraine.

Austria has continued to provide mine/UXO clearance teams during this reporting period in the framework of EUFOR ALTHEA and KFOR. Training programmes on mines and UXO's are implemented for all units conducting collective training as well as for all units during predeployment training for operations in Libanon (UNIFIL), Bosnia and Herzegovina (EUFOR ALTHEA), Kosovo (KFOR), Mali (EUTM) and Afghanistan (ISAF).
