Notes on using the cover page:

1. 2. The cover page can be used as a **substitute** for submitting detailed forms adopted at the First and Second Meetings of the States Parties only if all of the information to be provided in an annual report is the same as in past reports.
3. If an indication is made on the cover sheet that the information to be provided with respect to a particular form is **unchanged** in relationship to a previous year's form, the **date of submission** of the previous form should be clearly indicated.
