International Co-operation and Assistance

During the period covered by this report (2023), Sweden contributed at least 124 017 383 SEK to mine action in its wider sense – to clear all explosive remnants of war. Most of this support was channelled through the **Swedish International Development Cooperation Agency (Sida)**. For detailed information, please see Table 1

In the reporting period, the **Swedish Civil Contingencies Agency (MSB)** has supported mine action activities through UNMAS, OSCE, UNOPS and UNDP.

A long-term mine action support Ukraine has been initiated with two EOD-officers and a medical coordinator deployed to UNOPS in Ukraine, in support of the UNDP Mine Action Programme.

MSB has seconded a regional security specialist covering the Middle East, North Africa, Afghanistan and Colombia with the objective to improve the operational capacity in the UNMAS field programmes. The specialist develops and implements routines in order to ensure that all necessary security measures for operations in high-risk areas are in place for UNMAS to react and respond to humanitarian emergencies and support DPO missions within UNMAS' mandate in a timely manner.

The UNMAS Mine Action Centre in Ethiopia has received support by an information management officer. In Afghanistan, MSB has supported the UNMAS field programme with an information management officer and a senior operations officer. Also within its mandate to support peace operations, MSB has supported OSCE with mine action expertise; a Mine Action Project Officer in Montenegro. In support of the UNDP mine action programme in Yemen, MSB has supported with an Information Management Specialist.

During the period covered by this report, MSB has conducted technical training and exercises within Mine Action.

¹ The definition of Mine Action used includes the following elements: i) Mine awareness (measures to make people aware of and to inform people of the risks of mines and unexploded ammunition) ii) Demining (survey, mapping, marking, clearance) iii) Victim assistance (support to victims of mines, including rehabilitation and reintegration), iv) Advocacy (efforts to exert an influence in respect of limitation on the use of landmines and the total prohibition of anti-personal mines), v) Stockpile destruction (destruction of mines in stock). If "Mine Action" is indicated it implies a contribution integrating all the elements in the definition stated. If specific elements in the definition are indicated it implies that a contribution focuses on the indicated elements.
