



Thirteenth Meeting of the States Parties

2-5 DECEMBER 2013 • GENEVA

Presentations by States Parties which have completed or are in the process of implementing Article 5 of the Convention

(Agenda Items #9 and #11b)

- The six States Parties that have submitted requests for extended mine clearance deadlines (Chad, Mozambique, Niger, Serbia, Sudan and Turkey) are invited to make presentations on the main elements of their requests during Agenda Item #9 the afternoon of Monday 2 December. These presentations should last no more than 8 to 10 minutes. Following each presentation, the President of the Twelfth Meeting of the States Parties will present the corresponding analysis. The floor will then be open for any comments or questions on each request.
- The four States Parties that have announced or will announce completion of Article 5 implementation are invited to speak to officially declare completion at the beginning of Agenda Item #11b, which is notionally scheduled to start the morning of Wednesday 4 December but might start late in the afternoon on Tuesday 3 December. These presentations should be no longer than 7 to 8 minutes. The President will call upon these States Parties in accordance with their announced completion dates (i.e., Venezuela, Bhutan, Hungary and Germany). After all four have spoken, the floor will be open for any comments or questions.
- Following States Parties officially declaring completion, all States Parties implementing Article 5 which have been granted an extended deadline are invited to provide an update. Each of these States Parties, in an update that should be no longer than 7-8 minutes, is invited to provide clarity on the magnitude of what remains to be done (e.g., number of areas, total amount of area, etc.), on what more it intends to achieve by the end of 2014 (i.e., by the approximate timing of the Third Review Conference), and on key remaining challenges and plans to overcome them. The President will proceed according to extended deadline (i.e., earliest to latest). After each five to seven States Parties have spoken, the floor will be open for any comments or questions.
- Finally, all other States Parties in the process of implementing Article 5 will be invited to provide an update. Each of these States Parties, in an update that should be no longer than 7 to 8 minutes, is invited to provide clarity on magnitude of what remains to be done (e.g., number of areas, total amount of area, etc.), on what more it intends to achieve by the end of 2014 (i.e., by the approximate timing of the Third Review Conference), and on key remaining challenges and plans to overcome them. The President will proceed according to deadline (i.e., earliest to latest). After each five to seven States Parties have spoken, the floor will be open for any comments or questions.
- There is no need for the States Parties that are presenting their requests for extended deadlines under Agenda Item # 9 to again present under Agenda Item #11b.
