Fourteenth Meeting of the States Parties

30 November – 4 December 2015 | Geneva

## MONDAY 30 NOVEMBER 2015

- 12:00 **Opening of the exhibition “Recovering the past”, followed by a cocktail.** Hosted by the Presidency of the 14<sup>th</sup> Meeting of the States Parties. Location: in front of room XVIII.
- 13:00 **Cambodia's landmine contamination – strategy, completion and international cooperation and assistance.** Hosted by the Cambodia Mine Action and Victim Assistance Authority (CMAA) and UNDP Cambodia. His Excellency, Prum Sophakmonkol, Secretary General of the CMAA, will present the current situation and the future plans for the mine action sector in Cambodia as the country moves into the next stage of its mine action programming. The results of the Baseline Survey and Land Release results achieved since 2012 have provided a strong indication on the extent, scope and nature of the remaining landmine and ERW problem. Coordination and communication between international and national operators has assisted the CMAA to develop concrete and evidence-based plans and identify key actions, tools and resources required to achieve mine free status. The presentation will provide information on land release in Cambodia, including the results from the 2015 Land Reclamation Non-Technical Survey and Baseline Survey project funded by Clearing for Results Phase II.

Leading civil society experts will share the major findings of the Landmine Monitor 2015, detailing global and national developments in landmine ban policy, survey and clearance of landmines and explosive remnants of war, support for mine action, casualties and victim assistance.
- 13:00 **Nearing Completion – the Case of the Democratic Republic of the Congo.** Hosted by Norwegian People's Aid (NPA), the Congolese Centre for Mine Action (CCLAM) and UNMAS. Room XXII. Contact: [pehrl@npaid.org](mailto:pehrl@npaid.org). The CCLAM, NPA and UNMAS will present the progress made in the Democratic Republic of the Congo (DRC) and an outlook. The National Landmine Contamination Survey undertaken in 2013 resulted in 130 Suspected Hazardous Areas (SHA) recorded. Now, 18 months later there are only 85 SHA remaining. The deadline for DRC to meet its obligation under Article 5 of the Anti-Personnel Mine Ban Convention is 2021. At current rates, DRC should be able to meet these obligations already by 2017 with continued and increased donor support.

Room XXIV. Contact: megan@icblcmc.org. Results of and lessons learned from the Historic Agreement between the Colombian Government and the FARC to clear mined areas in the midst of ongoing conflict. How this pilot clearance project has protected the Colombian people and contributed to the peace process. What comes next for Colombia?

- 13:00 **Enhancing APMBC implementation through regional cooperation.** Hosted by the Geneva International Centre for Humanitarian Demining (GICHD). Room XXV. Contact: f.paktian@gichd.org. Timely and effective implantation of the APMBC remains a challenge especially in light of reduced international funding levels which are likely to continue in the next years. At the same time, through the 2014 Maputo Action Plan, States Parties are committed to an ambitious target to comply with treaty obligations to the fullest extent possible by 2025. New modalities of enhancing treaty implementation might be sought, in particular cooperation among States Parties at regional level is highly important. In fact, national mine action programmes of affected States have acquired substantive expertise over the last years which could make them a useful resource of national expertise from which other States Parties can benefit. In recent years, cooperation among affected States has taken place bilaterally or multilaterally, whereas linguistic platforms have also proven essential in bringing States together to define gaps and identify regional assets to fill them. Although regional cooperation has already provided positive outcomes in the past, it will become even more important and crucial in the future so that States Parties, expressing a need for assistance, will be better equipped to meet their targets and advance their programmes. This session will make participants aware of these platforms, their achievements, activities in the coming years, as well as lessons learnt. The event will be chaired by the Director of Operations of the GICHD, Guy Rhodes and will include speakers from Afghanistan, Cambodia and Croatia.

In April 2015, DDG in partnership with UNICEF conducted a knowledge, attitude and practice (KAP) survey. This exercise was unique in the sense that it was the first KAP survey around mine risk education (MRE) conducted in Ukraine and it addressed internally displaced people, returnees and resident concerns and perceptions of the danger attached to mines/ERW from the recent conflict.

So far, the Council of Ministers endorsed the legislative framework, policy and budget of the SEMA acknowledging SEMA as the legal entity responsible for managing and coordinating all explosive hazard management activities in Somalia. This year the mine action community has proven that it is possible to work in areas previously considered too dangerous, clearing remnants of past conflict and paving the way for peace and stability. The Federal Government has ratified the Cluster Munitions Convention as well. It will report on progress towards meeting its treaty obligations, and will outline its strategy to work towards a Somalia free from the threat of explosive hazards.
