Latest information on Covid-19 restrictions provided by the Government of the Netherlands

Current COVID-19 measures for events in the Netherlands prescribe the mandatory use of a Corona access pass to enter the conference venue of the 19MSP in the Hague.

If you do not have an European Corona access pass (QR-code), you can obtain one at the venue, if one of the following three conditions is met.

Full vaccination certificate

The vaccine you received must have been approved by the European Medicines Agency (EMA) or included on the Emergency Use Listing of the World Health Organization (WHO).

This is currently the case for the following vaccines:

- Astra Zeneca Japan (Vaxzevria)
- Astra Zeneca Australia (Vaxzevria)

- Pfizer/BioNTech (Comirnaty)
- o Johnson & Johnson ((COVID-19 Vaccine) Janssen)
- Moderna (Spikevax)
- Serum Institute of India (Covishield)
- Sinopharm BIBPSinovac

Negative test result

- o a negative NAAT (PCR) test result based on a sample collected no more than 48 hours
- o a negative antigen test result based on a sample collected no more than 24 hours

Recovery certificate

A recovery certificate indicating that you have been tested positive for COVID-19. Only recovery certificates issued in an EU Member State and no older than 180 days are valid.

If you meet any of the above conditions, you will receive a code with which you can use to download a QR-code in the Corona-check app or receive a QR-code on paper.

The Corona-check app can be downloaded from the Apple store and Play store.

Testing on location

Participants who are not able to provide any of the above, will be tested with a rapid antigen test on location at the World Forum. The procedure (registration, testing, waiting for result) will take about 20 minutes. The tests will be conducted by a professional health company authorized by the Ministry of Health.

Once you receive a negative test result, you will be able to download a QR-code in the Corona-check app or receive a QR-code on paper. This QR-code will be valid for 24 hours and gives you access to the conference venue and establishments in the Netherlands.

Should you receive a positive test result, you will not be able to obtain a Corona access pass and won't be allowed to enter the conference venue. In that case, you will need to follow the guidelines of the <u>Dutch government</u> immediately. After 11 days you will receive a certificate that shows that you tested positive for COVID-19 allowing you to travel.

Besides the mandatory Corona access pass, general protection measures will be put in place at the World Forum for the safety of both, Delegates and support staff. These measures include but are not limited to, good ventilation, 1.5 metre seating distance rule, availability of hand sanitizers and face masks, and standard cleaning protocol for all areas including desks.
