#### STATUS OF IMPLEMENTATION – VICTIM ASSISTANCE

### **COMMITTEE ON VICTIM ASSISTANCE**

(Algeria, Ecuador, Italy and Uganda)
Intersessional Meetings
20-22 June 2022

- 1. The Committee welcomes the submission by Jordan of updated information on its victim assistance activities.
- 2. Based on the information provided, the Committee presents the following preliminary observations.

#### Mine casualties

- 3. Jordan reported registering 1,018 mine survivors including 91 women and girls and 927 boys and men, with no casualty reported in 2021.
- 4. The Committee appreciates Jordan providing disaggregated data on annual casualties and welcomes such information on all casualties registered by Jordan. The Committee would welcome further information on mine victims that have been killed and information on indirect victims, such as affected families.

### **VICTIM ASSISTANCE ACTIONS:**

Strengthen partnerships and integrate victim assistance into broader national policies, plans and legal frameworks and designation of a Government entity to oversee the integration (Action #33 and also Actions #1 and #6)

- 5. Jordan reported that the National Authority for Demining and Rehabilitation (NCDR), under the guidance of the Higher Council for the Rights of Persons with Disabilities, continued to follow up assistance provided to mine victims.
- 6. Jordan reported that the needs and rights of mine survivors have been integrated into broader policies, especially those related to disabilities, including plans and policies developed for the implementation of the Convention on the Rights of Persons with Disabilities (CRPD).

Develop and implement measurable, realistic and time-bound national action plan (Action #33 and also Action #2)

7. The Committee recalls that in previous years Jordan reported on the integration of victim assistance into existing and emerging disability related plans and strategies and <u>welcomes information on mechanism</u> in place to oversee and measure progress and achievements of integrated plans, in relation to fulfilling Jordan's commitments under the Convention and the OAP.

Removing barriers including physical, social, cultural, political, attitudinal and communication barriers to access such services (Action #33)

8. The Committee welcomes Jordan to provide an update on progress made in this regard and in relation to lifting barriers that may hinder the participation of survivors and persons with disabilities in Jordan.

## Applying multi-sectoral efforts to ensure that the needs and rights of mine victims are effectively addressed in line with the Convention on the Rights of Persons with Disabilities (Action #34)

9. Jordan reported continued efforts in adopting a twin-track approach that relies on participatory management, accountability and transparency, through inclusive and comprehensive public policies for the rights of persons with disabilities and by implementing specific programmes to ensure the needs of mine and ERW survivors are met.

# Establish or strengthen of a centralised database / national information management system (Action #35 and also Action #9)

- 10. The Committee recalls that Jordan reported that a working group was created to follow up and update the national database of mine casualties and it would welcome information on progress made in this regard in 2021.
- 11. The Committee would also welcome information on integration of mine casualty data into relevant national databases, such as national disability database or injury surveillance registry.

## Access to first aid and ongoing emergency medical care (Action #36)

12. Jordan reported health care and rehabilitation are provided to mine survivors by the Royal Medical Services and the Ministry of Health (MOH) through Al-Bashir Hospital in the capital, Amman and through Royal Medical Services across the country.

### Developing national referral mechanism (Action #37)

13. The Committee would welcome information on the status of a national referral mechanism and directory of services or plan to develop them to further facilitate mine victims' access to services.

# Access to rehabilitation services including physiotherapy, assistive devices and occupational therapy (Action #38)

- 14. The Committee recalls that like in previous years, Jordan reported the availability of physical rehabilitation services by the Royal Medical Services and the MOH as well as by some private healthcare and rehabilitation centres.
- 15. The Committee welcomes Jordan providing information on number of mine victims who have received rehabilitation services in 2021 and further information on availability of occupational therapy for mine survivors and other persons with disabilities in Jordan.

## Access to psychological and psychosocial services including peer-to-peer support (Action #38)

- 16. Jordan reported that provision of psychological support was prioritized in 2021, like it was prioritised in 2020 and activities in this regard included home-based visits to all survivors especially those who needed psychological support.
- 17. The Committee would welcome information on number of mine survivors received psychological or psychological and peer support in 2021.

### Access to social and economic inclusion services, including in rural and remote areas (Action #39)

- 18. Jordan reported that the NCDR pays special attention to economic integration programs to raise the standard of living of survivors and their families.
- 19. The Committee would welcome information on measurable progress made with regards to social and economic inclusion of mine survivors and their families including in rural and remote areas, such as the number of mine victims that who have received tangible assistance to facilitate with their social and economic inclusion.

## Taking measure for safety and protection of mine survivors in situations of risks and emergencies (Action #40)

20. The Committee would welcome information from Jordan on measures that are in place or plan to ensure the safety and protection of mine survivors in situations of risks and emergencies including humanitarian emergencies, natural disasters.

# Strengthening inclusion and participation of mine victims and their representative organisations in all matters that affect them (Action #41 and also Action #4)

21. Jordan reported ensuring the participation of mine survivors and persons with disabilities relevant programmes, including decision-making, public policies and into relevant conferences, on the basis of respect for human rights, gender equality and non-discrimination.

## **CROSS - CUTTING ACTIONS:**

## Demonstrate high levels of national ownership, including [...] by making financial and other commitments to implementation (Action #1)

22. Jordan reported national budgetary allocation of 220,000 dinars to the NCDR. <u>The Committee</u> would welcome further information on allocation of financial and other commitments, by the Government of Jordan, to victim assistance activities.

## Ensure that the different needs and perspectives of women, girls, boys and men are considered (Action #3)

23. Jordan reported that gender equality and non-discrimination are considered in Jordan's victim assistance efforts.

### Challenges in implementation of Victim Assistance Commitments (Action #8)

24. The Committee would welcome information on challenges in provision of Victim Assistance and information on how the international community can assist Jordan in fulfilling its Victim Assistance commitments under the Convention and the OAP.
