The National Stakeholders Dialogue on Humanitarian Demining hosted by Zimbabwe from January 24–26, 2023.









PROGRESS TO DATE











As at 31 October 2023, the area cleared since independence amounts to 294,13 km². Translates to 94.7% total area released.

Remaining contamination is at 16,53 km² translating to 5.3% to be tackled up to December 2025.

Our target for the 2023 demining calendar year was to release a total of 6,385,766 m².
