The Fifth Review Conference of the States Parties to the Anti-Personnel Mine Ban Convention – *The Siem Reap* – *Angkor Summit on a Mine-Free World* - will be held from **25 to 29 November 2024** at the **Sokha Siem Reap Resort & Convention Centre**, Siem Reap, Cambodia.

1. Opening of the Review Conference

The Fifth Review Conference will be opened by the President, **His Excellency Dr. Ly Thuch**, Senior Minister and First Vice-President of the Cambodian Mine Action and Victim Assistance Authority.

The opening ceremony will be presided over by **Samdech Moha Borvor Thipadei HUN Manet**, Prime Minister of the Kingdom of Cambodia, who will deliver the keynote address and will include high level participation from the United Nations, the ICRC and a representation of mine survivors and the ICBL.

6. Renewing the political commitment to the Convention – High level segment

During this agenda item, high level <u>heads of delegations(e.g., Head of State or Government, Minister or</u> <u>Deputy-Minister</u>) will be invited to renew their political commitment to the Convention through the delivery of a statement of <u>up to 6 minutes</u>. (Note: statements will be delivered from the lectern on the stage).

These heads of delegations are encouraged to outline their vision for the future of the Anti-Personnel Mine Ban Convention and share their country's plan to support implementation.

In the establishment of a speakers' list, precedence will be given to States Parties represented at a high level prior to statements being delivered by high level representatives of observer delegations. In keeping with past practice, brief messages may also be delivered by organisations represented at a high level or by individuals invited to do so.

After delivering their statements, high level <u>heads of delegations of States Parties</u> will be escorted out of the conference room and may proceed to sign a ceremonial copy of the Siem Reap Angkor Declaration on a Mine-Free World. <u>Heads of Observer delegations</u> may proceed and sign a *witness sheet*. She or he may bring into the signing room others who she or he wishes to witness this event.

A photographer will record each ceremonial signing.

In keeping with past practice, States Parties requesting extensions will be given the opportunity to present a brief summary of their request (speaking time up to 8 minutes). Following each presentation, the Chair of the Committee on Article 5 Implementation will present a brief analysis of the request, after which the floor will be open for comments, questions or views on the request.

States Parties will have until Wednesday to consult one another on the extension requests before they turn to formal consideration of these requests on **Thursday 28 November 2024**.

<u>States Parties responsible for destroying stockpiled anti-personnel mines</u>¹ will be given the opportunity to provide updates on their efforts to complete the destruction of stockpiled anti-personnel mines and reflect on their State's main accomplishments in this regard since the Fourth Review Conference, share their remaining challenges and how they intend to overcome them.

<u>States Parties that have discovered previously unknown stockpiles</u> will also be invited to provide brief updates on their efforts to fulfil their destruction obligations.

<u>Other delegations</u> may comment on the stockpile destruction aspects of the proposed outcome documents or otherwise share views on stockpile destruction.

Delegations are encouraged to include information in their statement concerning their efforts to ensure consideration for gender and the diverse needs of mine affected communities as well environmental considerations in their implementation efforts.

<u>Other delegations</u> may comment on the mine clearance and mine risk education and reduction aspects of the Siem Reap Angkor Action Plan or otherwise share views on mine clearance and on how the Siem Reap Angkor Action Plan will be implemented nationally during the period 2025-2029.

Angkor Wat Temple, the heritage of humanity and world wonder, was declared by UNESCO on 14 December 1992 as 'Tangible Cultural Heritage'. Angkor Wat is considered one of the most important archaeological sites in Southeast Asia. The largest religious monument in the Angkor complex, Angkor Wat is an architectural masterpiece, with its perfect composition, balance, proportions, reliefs, and sculpture making it one of the finest monuments in the world.

Appropriate attire when visiting temples in Angkor Wat is long pants (covering the knee) and shirts that cover the shoulders. Skirts, small shorts, tank tops, and other items of revealing clothing are not allowed within

<u>All delegations</u> will be given the opportunity to share views on cooperation and assistance (5 minutes) and reflect on their accomplishments in cooperation and assistance since the Fourth Review Conference, their remaining challenges and on these can be overcome in the next five years.

Delegations are encouraged to include information in their statement concerning their efforts to ensure consideration for gender and the diverse needs of mine affected communities as well environmental considerations in their cooperation and assistance efforts.

<u>All delegations</u> may comment on the cooperation and assistance aspects of the Siem Reap Angkor Action Plan or otherwise share views on cooperation and assistance and how the Siem Reap Angkor Action Plan will be implemented nationally during the period 2025-2029.

The incoming Chair of the Committee on the Enhancement of Cooperation and Assistance will present their priorities for implementation for 2025.

(ii) Transparency in implementation

An invited keynote speaker will be invited to offer opening remarks.

The President will detail how transparency has been addressed in the proposed outcome documents of the conference.

<u>All delegations</u> will be given the opportunity to share views (5 minutes) on transparency and reflect on their accomplishments in relation to transparency since the Fourth Review Conference, their remaining challenges and on these can be overcome in the next five years.

<u>All delegations</u> may comment on the transparency aspects of the Siem Reap Angkor Action Plan or otherwise share views on cooperation and assistance and how the Siem Reap Angkor Action Plan will be implemented nationally during the period 2025-2029.

(iii) Measures to ensure compliance

An invited keynote speaker will be invited to offer opening remarks.

The President will detail how compliance has been addressed in the proposed outcome documents of the conference.

The President, in his capacity of Chair of the Committee on Cooperative Compliance, will provide brief comments and present their conclusions and recommendations.

<u>States Parties with alleged non-compliance</u>⁴ will be given the opportunity to provide brief updates on the situation in their State, on ongoing investigations and on measures in place to prevent and suppress activities prohibited by the Convention.

<u>All delegations</u> will be given the opportunity to share views (5 minutes) on compliance and reflect on their accomplishments in compliance since the Fourth Review Conference, their remaining challenges and on these can be overcome in the next five years.

<u>All delegations</u> may comment on the compliance aspects of the Siem Reap Angkor Action Plan or otherwise share views on compliance and how the Siem Reap Angkor Action Plan will be implemented nationally during the period 2025-2029.

The incoming Chair of the Committee on Cooperative Compliance will present their priorities for implementation for 2025.

(iv) Implementation support

The implementation of the Anti-Personnel Mine Ban Convention is facilitated by an implementation machinery, which comprises a President and four Committees as established by the Third Review Conference in 2014 and amended at the Fourth Review Conference in 2019. The Fifth Review Conference provides an opportunity to review the Convention's machinery.

The President will present his report on the meeting programme and machinery 2025 – 2029. The Conference will be asked to adopt a set of decisions based on the recommendations made in the President's report.

<u>All delegations</u> may comment on the implementation aspects of the proposed outcome documents of the Conference, including on any aspect of the proposed machinery that have not been discussed during previous agenda items. Delegations also may share other views on implementation support.

Further to the "Directive from the States Parties to the ISU" adopted by the 10MSP and the decisions of the 14MSP on strengthening financial governance and transparency, the ISU Director will present the following:

- The ISU's Five Year Work Plan and Budget 2025-2029 which was endorsed by the Coordinating Committee, in line with the decision of the Fourteenth Meeting of the States Parties;
- The work plan and budget for the activities of the ISU in 2025;
- The report on the 2024 ISU activities, functioning and finances; and
- The ISU's audited financial report for 2023.

<u>Delegations</u> will be given the opportunity to provide comments and/or share their views on the ISU five-year work plan and budget, the work plan and budget 2025, the 2023 audit report, and the 2024 preliminary financial report.

Furthermore, on 25 July 2024, the President circulated a proposal to extend the tenure of the current Director of the ISU until 30 April 2027 with the incoming President (Japan (2025) and the President of the Twenty-Third Meeting of the States Parties, Zambia (2026)) tasked to work closely to develop an effective and well-planned recruitment process to ensure a smooth transition.

<u>Delegations</u> will be asked to agree on the extension of the current Director until 30 April 2027.

Committee membership:

In keeping with its mandate, in 2024 the President of the Fifth Review Conference undertook the task of consulting with States Parties to identify a list of nominees to serve as new Committee members following the Fifth Review Conference. On 1 April 2024, the President wrote to all States Parties to indicate that it was seeking two new States Parties for each of the four Committees for two-year terms. On the basis of interest expressed, the President has developed a proposal listing of States Parties to serve as new Committee members from the end of the Fifth Review Conference for a two-year term.

Delegations will be asked to agree on the proposed set of new officeholders (see proposal in Annex I).

The Conference will be asked to adopt decisions with respect to requests for extended mine clearance deadlines which have been or are due to be submitted by Afghanistan, Chad, Cyprus, Eritrea, Guinea Bissau, Niger, Peru and Serbia.

12. Dates, duration and locations of future meetings

Decisions for Meetings of the States Parties:

It is proposed that the Conference agree that, beginning in 2025, a Meeting of the States Parties be convened each year at the end of November or beginning of December until the end of 2028, and that the Sixth Review Conference will be held at the end of 2029.

It is further proposed that the Conference agree to hold the Twenty-Second Meeting of the States Parties in Geneva, Switzerland during the week of 1 to 5 December 2025.

Decisions for Intersessional Meetings

It is proposed that the Conference agree that Intersessional Meetings continue to be held annually in Geneva for a minimum of three days of plenary meeting.

Taking into account the need to allow ample time for discussions between the Convention's machinery and representatives of States Parties, States not party and other stakeholders on matters related to implementation of the Convention and the Siem Reap – Angkor Action Plan, the Conference will be further asked to agree that, the President in consultation with the Coordinating Committee considers and decides adding on an annual basis, one day to dedicate to bilateral meetings or to discuss thematic matters related to implementation.

It is further proposed that the Conference agree to set the dates of the Intersessional Meetings the week of 16-20 June 2025.

13. Recommendation for adoption of the final documents

The President will ask the Conference to recommend for adoption the Conference's final documents.

Annex I – Decisions to be taken by the Fifth Review Conference

a. Article 5 extension requests

The Fifth Review Conference will need to take decisions on the request for extensions under Article 5 submitted/ to be submitted by **Afghanistan, Chad, Cyprus, Eritrea, Guinea Bissau, Niger, Peru** and **Serbia**. Submitted requests and additional information received has been posted on the Convention's website. The Committee on Article 5 Implementation has prepared an analysis of each request received which are available on the Convention's website.

b. Documents to be considered

The Fifth Review Conference will adopt three substantive outcome documents, a *Review of the General Status of Implementation of the Convention 2019-2024*, the *Siem Reap – Angkor Action Plan 2025-2029* and a *Siem Reap-Angkor Declaration on a Mine-Free World 2024*.

The Fifth Review Conference will also welcome the report of the four thematic Committees on *Status of implementation of the Convention by States Parties with outstanding obligations*.

c. Appointment of new Committee members

At the Fifth Review Conference, the States Parties will be asked to consider a proposed set of new officeholders for agreement. In this regard, the President has developed a balanced proposal for new officeholders taking into account the expressions of interest received:

- Committee on Victim Assistance: Austria and Sri Lanka
- Committee on Article 5 Implementation: Algeria and Norway
- Committee on the Enhancement of Cooperation and Assistance: Cameroon and Switzerland
- Committee on Cooperative Compliance: Belgium and Cambodia

If this proposal is agreed to by the Fifth Review Conference, the proposed States Parties would join the following States Parties which have already been Committee members for a year and will stay on the Committees until the end of the Twenty-Second Meeting of the States Parties:

- Committee on Victim Assistance: Burkina Faso and the Netherlands
- Committee on Article 5 Implementation: Thailand and the United Kingdom
- Committee on Enhancement of Cooperation and Assistance: Denmark and Türkiye
- Committee on Cooperative Compliance: Germany and Peru

d. Implementation Support Unit

The Fifth Review Conference will also need to adopt the ISU's 2024 interim report, the 2023 audited report, its work plan and budget for 2025-2029, and its work plan and budget for 2025. The work plans presented by the ISU have been developed in line with the decision of the Fourteenth Meeting of the States Parties on *strengthening financial governance and transparency within the ISU*.

Furthermore, States Parties will be asked to approve the proposed extension of the term of the current Director of the ISU until 30 April 2027. This follows a silence procedure launched on 25 July 2024 in which no reservations were expressed.

e. Report on the meeting programme and machinery 2025 - 2029

The President will present his report on the meeting programme and machinery 2025 – 2029. The Conference will be asked to adopt a set of decisions based on the recommendations made in the President's report.

f. Dates, duration and location of future meetings

States Parties will be asked to take a decision on dates, duration and location of future meetings.

Twenty-Second Meeting of the States Parties

The Twenty-First Meeting of the States Parties decided to hold the Twenty-Second Meeting of the States Parties end of November – beginning of December 2025 and to elect Ambassador Tomiko Ichikawa, Permanent Representative of Japan to the Conference on Disarmament, as the President of the Twenty-Second Meeting.

At the Fifth Review Conference, the States Parties will be asked to agree that the Twenty-Second Meeting of the States Parties take place in Geneva, Switzerland, on 1-5 December 2025.

The Meeting adopted the estimated costs of the Twenty-Second Meeting, as contained in APLC/MSP.20/2022/14/Rev.1.

Twenty-Third Meeting of the States Parties

The Twenty-First Meeting of the States Parties decided to elect Ambassador Eunice Tembo Luambia, Permanent Representative of Zambia to the United Nations in Geneva, as the President of the Twenty-Third Meeting of the States Parties.

At the Fifth Review Conference, the States Parties will be asked to adopt the estimated costs of the Twenty-Third Meeting of the States Parties.

Meetings of the States Parties beyond the Twenty-Third Meeting of the States Parties

The Fifth Review Conference will be asked to elect any future presidencies based on expressions of interest submitted to the States Parties.

Intersessional Meetings

States Parties will be asked to agree that the next Intersessional Meetings take place in Geneva, Switzerland, the week of 16-20 June 2025.
