









# Zimbabwe's National Stakeholder Dialogue: Humanitarian Demining and Assistance to Mine Victims, the Path Forward

Harare, 18-20 February 2025 | Final Programme

# **Background**

Zimbabwe, which has suffered the devastating effects from the use of anti-personnel mines placed in the country in the 60s and 70s, was among the world's first countries to join the 1997 *Convention on the Prohibition of the Use, Stockpiling, Production, and Transfer of Anti-Personnel Mines and on Their Destruction* (also known as the AP Mine Ban Convention or Mine Ban Treaty).

By joining the Convention, Zimbabwe undertook to implement various obligations including Article 5, which calls on the State Party to "undertake to destroy or ensure the destruction of all anti-personnel mines in mined areas under its jurisdiction or control" along with other preventive measures. It also accepted to "provide assistance for the care and rehabilitation, and social and economic reintegration of mine victims and for mine awareness programs" as enshrined in Article 6.3. The latter concept known as *victim assistance* (VA), is a rights-based approach that sees its implementation being attached to a State Party's wider efforts to meet its Sustainable Development Goals and the rights of all persons with disabilities.

Within the Convention's framework, Zimbabwe has until 31 December 2025 to finalise clearance operations. While this milestone is at the fingertips, remaining barriers prevent the State Party from fulfilling the Article 5 obligation within this timeframe. Zimbabwe will therefore have to present a request to extend its mine clearance deadline. By decision of the States Parties, such requests should take into consideration feedback from stakeholders – including from mine-affected communities and their representative organisations – as well as partners. As Zimbabwe prepares for the imminent end of its clearance operations, the State Party will also need to start devising a plan for what it will need to do to address any residual contamination post completion.

In addition, assistance to mine victims – an obligation that has no expiration date – needs to be solidly incorporated in Zimbabwe's national development programmes and those covering the rights of persons with disabilities and will have to continue beyond mine clearance operations.

In this context, the Zimbabwean Mine Action Centre (ZIMAC) and the National Mine Action Authority (NMAA) under the Ministry of Defence, are the national structures for implementing aspects related to Article 5. VA implementation is carried out by the Ministry of Public Service, Labour and Social Welfare. These national agencies will therefore jointly host a **National Stakeholder Dialogue on Humanitarian Demining and Victim Assistance from 18-20 February 2025 at the Rainbow Hotel**.

Technical backing for the Dialogue, is provided by the Convention's Implementation Support Unit (ISU), while the financial support is provided by the Council of the European Union (EU) which adopted Decision 2021/257 "in the framework of the European Security Strategy and in accordance with relevant Decisions of the international community" to support implementation of the Convention.

Zimbabwe ratified the CRPD in 2013 and adopted its first National Disability Policy (NDP) in 2021, offering a comprehensive framework for the rights of persons with disabilities including mine survivors. That year, Zimbabwe commissioned a study to analyse the state of the rights of persons with disabilities, which provided a comprehensive analysis. The MPLSW through its Department of Disability Affairs has been mandated to lead implementation of the NDP. Action 32 of the SRAAP calls on States Parties to "carry out efforts to identify all mine and other explosive ordnance victims and collect accurate and comprehensive information on their needs, challenges and geographic locations in a manner disaggregated by gender, age, disability, and other considerations, making data on mine and other explosive ordnance victims available to relevant stakeholders including by integrating this data into a national centralised database, such as disability data systems." Article 26 of the CRPD requires the States Parties to provide *habilitation* and rehabilitation including assistive devices, which is complemented by Action 35 of the Siem Reap-Angkor Action Plan. The NDP outlines ten objectives in this area and assigns the Ministry of Health and Child Care the responsibility of working with the Department of Disability Affairs to deliver these services.
