Statement under agenda item 7a. Universalization

Ms. President¹,

This statement is delivered on behalf of the United Nations Inter-Agency Coordination Group on Mine Action (IACG-MA)².

Excellencies.

The United Nations are gravely concerned by announcements and steps taken by several States Parties to withdraw from the Anti-Personnel Mine Ban Convention. Such announcements are a significant setback for a 28-year-old multilateral Treaty that has saved countless lives.

Moreover, this development represents a troubling erosion of support for the humanitarian disarmament treaties that are fundamental for the protection of human life and dignity. Withdrawal

from humanitarian disarmament treaties severely weakens the protection of civilians and risks lives.

Adopted in 1997, the Convention is a landmark achievement. **Its** prohibition of the use, production, stockpiling, and transfer of anti-personnel mines reflects a widely held understanding that the humanitarian, social and economic consequences of their use far outweigh any perceived military utility.

We urge all States considering withdrawal to reassess their decisions and halt steps towards this end.

We call on the 32 States that have yet to join the Convention to do so without delay and to fully commit to its objectives. **It is** precisely when civilians are at increased risk from widening conflicts that we must strengthen rather than weaken these vital normative frameworks.

To this end, and as announced in his recent statement on the matter, the Secretary-General has launched a global campaign to uphold the norms of humanitarian disarmament, accelerate mine action as an enabler for the enjoyment of human rights and sustainable development, and drive forward the vision for a mine-free world.

We warmly welcome the recent accession of the Republic of the Marshall Islands to the Anti-Personnel Mine Ban Convention and are encouraged by the progress made by Tonga and Micronesia in its accession process. We commend the President of the 22MSP, the Committee on Universalization and the ISU for their efforts to further universalize the Convention.

Statement of the Secretary-General

At a time when civilians face heightened risks from widening conflicts, it is imperative that we strengthen the frameworks that protect human life and dignity. I am gravely concerned by recent announcements and steps taken by several Member States to withdraw from the Anti-Personnel Mine Ban Convention.

These announcements are particularly troubling, as it risks weakening civilian protection and undermining two decades of a normative framework that has saved countless lives. I urge all States to adhere to humanitarian disarmament treaties and immediately halt any steps towards their withdrawal. I also appeal to the 32 States that have yet to join the Anti-Personnel Mine Ban Convention to do so without delay and to fully commit to its objectives.

To this end, I intend to launch a global campaign to uphold the norms of humanitarian disarmament, accelerate mine action as an enabler of human rights and sustainable development, and drive forward the vision of a mine-free world. To achieve these aims, over the next six months this campaign will aim to re-energize public support for disarmament, and will also facilitate concrete actions by States to uphold humanitarian norms and strengthen mine action.
