1. The Committee welcomes the submission by Mali of updated information on its victim assistance activities. Based on the information provided, the Committee presents the following preliminary observations.

VICTIM ASSISTANCE ACTIONS:

Ensure that a relevant government entity in affected States Parties is assigned as the focal point to coordinate victim assistance and oversee and enhance the integration of victim assistance activities into broader national policies, plans, budgets, and legal frameworks (Actions 30, 1 and 2)

 The Committee would welcome information on government entity assigned as the focal point of Mali to coordination victim assistance and oversee the integration of victim assistance into broader frameworks.

Develop a national specific, measurable, realistic, and time-bound disability action plan (Actions 30 and 3)

3. <u>The Committee would welcome information on existence or development of national plan that guide victim assistance efforts.</u>

Include mine and other explosive ordnance victims or their representative organisations, in victim assistance planning and implementation at the national and local level (Actions 30, 31 and 39)

4. <u>The Committee would welcome information on inclusion of mine and other explosive ordnance (EO) survivors or their representative organisations in planning and implementation activities.</u>

Report on progress and challenges in implementing their national action plans (Action 30)

5. Mali reported on provision of healthcare, rehabilitation and psychological services as well as challenges such as lack of resources impeding victim assistance implementation.

Carry out inter-ministerial and multi-sectoral efforts to ensure that the needs and rights of mine and other explosive ordnance victims are effectively addressed (Action 31)

6. <u>The Committee would welcome information on inter-ministerial and multi-sectoral efforts including</u> information on inter-ministerial coordination.

Identify all mine and other explosive ordnance victims and collect accurate and comprehensive information on their needs, challenges and geographic locations in a manner disaggregated by gender, age, disability, and other considerations (Action 32 and Action 9)

- 7. Mali reported a total of 351 civilian victims of which 129 have received assistance, including 54 women (29%), 110 men (58%), 10 girls (5%), and 15 boys (8%).
- 8. The Committee would welcome a clarification on whether the 351 victims are new casualties registered in 2024. Also, the Committee would welcome further information, disaggregated by gender, age and disability, on all casualties recorded in Mali.

Integrate the data on mine and other explosive ordnance victims into a national centralised database, such as disability data systems (Actions 32 and 9)

9. <u>The Committee would welcome information on efforts made to integrate the data on mine and other EO victims into a national centralised system, such as disability or injury surveillance.</u>

Provide effective and efficient context-specific emergency medical care to new casualties and improve national capacity through training, including on psychosocial first care, specialized training for health professionals and layperson first responder training in affected communities (Action 33)

10.Mali reported on availability of first aid, provided through community healthcare workers and in some cases, with support of NGOs.

Ensure that mine and other explosive ordnance survivors have access to health services including in rural and remote areas (Action 33)

11.Mali reported that there is national capacity within several referral health centres (known as CSREFs) to provide first aid to new casualties, with some support provided by NGOs. Mali reported that severe casualties are referred to regional hospitals for specialised and advanced services.

Ensure that a national/sub-administrative area referral mechanism is in place to facilitate access to services (Action 34)

12. Mali reported that mine and other EO victims benefit from referrals made by community health centre (known as CSCOM) and other healthcare and rehabilitation stakeholders.

Create and disseminate a comprehensive directory of services available, accessible, and inclusive for all mine and other explosive ordnance victims (Action 34)

13. The Committee would welcome an update in this regard.

Efforts to increase the availability and accessibility of rehabilitation services (Action 35)

- 14. Mali reported on availability of rehabilitation services, provided by the National Orthopaedic Center for the Disabled in Mali (known as CNAOM), the private Father Bernard Verspieren Center in Bamako, and Regional Centers for Functional Rehabilitation and Re-education (CRAORF) in Mopti, Gao, Tombouctou, Ségou, and Kayes.
- 15. Mali reported that rehabilitation faces challenges such as shortages in specialised human resources and finances, with only 13 ortho prosthetists for the whole country.

Ensure to provide assistive technology (Action 35)

16. Mali reported on availability of services, as such as those offered by CNAOM and CRAORF providing rehabilitation including assistive technology.

Increase resources and national capacity to make assistive technology affordable and accessible (Action 35)

17. Mali reported that in 2023 a new ortho prosthetist training centre was launched by CNAOM and the National Institute of Health Sciences, to address gaps in specialised human resources.

Ensure mine victims have access to psychological and psychosocial support services including to mental health (Action 36)

- 18. Mali reported on provision of limited mental health support offered through regional hospitals and some referral centres.
- 19. The Committee would welcome further information in this regard.

Efforts to make peer-to-peer support availability including by integrating it into public healthcare and other relevant systems (Action 36)
