- States Parties that have been requested to submit updated work plans in accordance with decisions on their requests for extension will be invited to provide an overview of their updated work plans (Bosnia and Herzegovina, Chad, Guinea-Bissau, Niger and Ukraine);
- Other States Parties implementing Article 5 will be invited to present on their progress in meeting their deadlines (Afghanistan, Cyprus, Eritrea, Iraq, Mauritania, States of Palestine, Peru, Serbia, Somalia, Sri Lanka, Sudan, Thailand, and Yemen);
- States Parties and organisations wishing to engage regarding the Committee's preliminary observations or matters related to Article 5 will be invited to take the floor.

#### 4b. Mine Risk Education and Reduction

- Mine Affected States Parties will be invited to present their progress and challenges in the implementation of mine risk education and reduction programmes;
- States Parties and organisations wishing to engage on matters related to mine risk education and risk reduction under Article 5 will be invited to take the floor.

The Siem Reap-Angkor Action Plan acknowledges the challenges in financing mine action and commits both mine affected and donor States to collaborate and foster increased cooperation and assistance, including through exploring "all possible funding sources including conventional and alternative/innovative sources and mechanisms of funding such as front loading models."

This panel will explore the situation regarding global mine action funding and progress made in exploring new opportunities, including voluntary trust fund, innovative financial mechanisms and context specific funding modalities.

Thematic Panel B (Tentative): Strengthening synergies between the Anti-Personnel Mine Ban Convention and the Women Peace and Security agenda through concrete action

The Siem Reap-Angkor Action Plan recognizes that the implementation of the Convention contributes significantly to advancing other international framework and commitments such as those enshrined in the Women Peace and Security agenda (UNSC 1325).

One of the priorities of the President of the Twenty-Second Meeting of the States Parties is to explore, together with States Parties and stakeholders, concrete approaches and initiatives to further enhance the synergies between the Convention's implementation and the WPS agenda.

The Panel will explore the links between the WPS agenda and the Convention as well as ways to strengthen synergies.

#### 7a. Universalization

Under this agenda item, the President will provide an overview of key decisions of the Fifth Review Conference, the President's activities related to implementation of the universalization commitments of the SRAAP (Actions 11 to 12) and the way forward.

The President will invite delegations to offer updates on their efforts and challenges on matters related to universalization as follows:

- States not party will be invited to take the floor to offer an update on efforts to acceed/ratify the Convention and to further algin themselves with the Convention;
- States Parties and organisations wishing to engage regarding the matters related to universalization will be invited to take the floor.

#### 7b. Stockpile destruction and retained mines

Under this agenda item, the President will provide an overview of key decisions of the Fifth Review Conference, the President's activities concerning implementation of the stockpile destruction and retained mines commitments of the SRAAP (Actions 13 to 16).

The President will invite delegations to offer updates on their efforts and challenges on matters related to stockpile destruction and retained mines as follows:

- States Parties that have missed their Article 4 deadlines (Greece and Ukraine) will be invited to offer updated information on the implementation of their stockpile destruction commitments in accordance with the SRAAP (Action 14);
- States Parties that have discovered previously unknown stockpiled mines will be invited to take the floor to offer an update in line with the SRAAP (Action 15);
- States Parties that retain anti-personnel mines for training and other permitted purposes will be invited to provide information on their efforts to review the number of mine retained and the reasons for retaining such anti-personnel mines under Article 3 including plans for the use of these mines and efforts to explore alternatives in accordance with the SRAAP (Actions 16);
- Other States Parties and organisations wishing to engage on matters related to stockpile destruction and mines retained under Article 3 will be invited to take the floor.

#### 7c. Establishment of the Working Group on voluntary trust fund

Action 44 of the Siem Reap-Angkor Action Plan states that "States Parties in a position to provide assistance will strengthen efforts to effectively coordinate their support for the effective implementation of Convention obligations by affected States Parties.....As part of this effort, States Parties will explore the feasibility of establishing a voluntary trust fund to support affected States Parties struggling to secure international assistance for their legal and time-bound commitments under Article 5 of the Convention, with a view to reporting on the progress made to the Twenty-Second Meeting of the States Parties and to taking a decision thereon by no later than the Twenty-Third Meeting of the States Parties."

The Fifth Review Conference mandated the President of the 22MSP to "establish a working group to support the implementation" of this Action.

The President will provide an update on implementation of this mandate and will invite the Working Group to offer an update of the status of activities. and the floor will then be opened for questions and comments from States Parties and organisations.
