VICTIM ASSISTANCE

Implementation of the **Republic of Angola's** commitments under the Siem Reap-Angkor Action Plan (SRAAP), Actions 30 -31



Focal Point - **ANAM** responsible for **coordinating** victim assistance as part of the Mine Action Programme in Angola, (*Action 30*).

ANAM supervises and advocates to improve the integration of victims in order to safeguard their rights, well-being and sustainability.

Victim Assistance has been integrated into national **policies and plans** on health, human rights, education, disability, gender and diversity, labour, poverty reduction and social protection.

VICTIM ASSISTANCE

Implementation of the **Republic of Angola's** commitments under the Siem Reap-Angkor Action Plan (SRAAP), particularly Actions 30

National Plan for the Inclusion and support of People with Disabilities (PLANIAPED 2023-2027) and integrates the government's objectives and actions for the inclusion, protection and support of people with disabilities.

VICTIM ASSISTANCE

Implementation of the **Republic of Angola's** commitments under the Siem Reap-Angkor Action Plan (SRAAP), particularly Actions 30

The Plan is aligned with the **United Nations 2030 Sustainable Development Goals**, as well as the recommendations of the **United Nations Committee on the Rights of Persons with Disabilities** regarding the **Sustainable Development Goal**

The principles governing the development of the plan, which are inspired by two (2) main documents ratified by Angola: **the Convention on the Rights of Persons with Disabilities** - CRPD, 2006 and the **Protocol to the African Charter on Human and Peoples' Rights on the Rights of Persons with Disabilities in Africa**.

VICTIM ASSISTANCE

ANAM works closely and in coordination with the main ministerial departments and other partner institutions and organisations, ensuring that the social services provided **across these institutions** meet the needs and rights of victims and their families.

- **Coordination meetings with the focal points (on a regular basis)** - to implement and monitor the actions set out in the National Plan and Seam Reap Action Plan;
- **To present coherent, sustainable and technically viable proposals** - for better inclusion of victims and their families.

VICTIM ASSISTANCE

Implementation of the **Republic of Angola's** commitments under the Siem Reap-Angkor Action Plan (SRAAP), particularly Actions 31

ANAM, as the coordinator of victim assistance, monitors and follows up on the progress of the implementation of the measures included in the Plan

- **Monitoring visits to the various institutions involved in this process (on a regular basis) - to assess the degree of implementation of actions;**
- **Analysis of technical, statistical and progress reports (monthly) on activities/actions/interventions.**

CHALLENGES

- The plan is not specific to victims, which makes it difficult to provide targeted assistance to victims;
- Difficulty in extending and guaranteeing services in rural areas;
- Inequality and disparity in access to services and opportunities for victims and their families;
- Insufficient funding for all stakeholders;
- Budget constraints that hinder the comprehensive implementation of plans and programmes;
- Inadequate infrastructure for physical accessibility, transport and inclusive education;
- Lack of adequate training among health professionals to deal with the needs of victims and their families.
