### THE 2–5 DECEMBER 2013 THIRTEENTH MEETING OF THE STATES PARTIES (13MSP) IS THE LAST ANNUAL ASSESSMENT

of the application of the Cartagena Action Plan 2010–2014, which was adopted at the 2009 Cartagena Summit, prior to Convention's Third Review Conference in 2014. This assessment of challenges encountered and work that remains to be done will be recorded in the 13/MSP's Geneva Progress Report.

Efforts to prepare for the Third Review Conference get underway on 6 December at the First Preparatory Meeting. Both meetings take place in Room XIX at the Palais des Nations in Geneva. Also during the week of 2–6 December, various actors will convene over 20 side events.

# THIRTEENTH MEETING OF THE STATES PARTIES: ANNOTATED PROGRAMME



H.E. Boudjemâa Delmi, Ambassador and Permanent Representative of Algeria to the United Nations (Geneva), will preside over the 13MSP.

# MONDAY 2 DECEMBER, 10:00 - 13:00

#### Official opening of the meeting

The meeting will be opened by the President of the Twelfth Meeting of the States Parties (12MSP), H.E. Matjaz Kovacic, Ambassador and Permanent Representative of Slovenia to the United Nations (Geneva).

#### 2 Election of the President

The meeting will be asked to elect H.E. Boudjemâa Delmi, Ambassador and Permanent Representative of Algeria to the United Nations (Geneva), as President of the 13MSP.

#### 3 Ceremonial opening of the Thirteenth Meeting

The 13MSP will begin with brief addresses by or on behalf of the UN Secretary General, the President of the International Committee of the Red Cross, the International Campaign to Ban Landmines and the President of the Council of Foundation of the Geneva International Centre for Humanitarian Demining.

#### 4 Adoption of the agenda

The meeting will be asked to adopt its agenda, which was presented to delegations on 30 May at the meeting of the Standing Committee on the General Status and Operation of the Convention.

#### 5 Election of the Vice-Presidents

The meeting will be asked to elect the ten Co-Chairs of the Standing Committees as Vice-Presidents of the 13MSP: Austria, Bulgaria, Colombia, Ecuador, Mozambique, New Zealand, the Netherlands, Nigeria, Norway and Thailand.

#### 6 Confirmation of the Secretary-General

The meeting will be asked to confirm, as Secretary-General of the 13MSP, H.E. Urs Schmid, Ambassador and Permanent Representative of Switzerland to the Conference on Disarmament.

#### 7 Organisation of work

The meeting will be asked to adopt its programme, which was presented to delegations on 30 May at the meeting of the Standing Committee on the General Status and Operation of the Convention.

#### 8 General exchange of views

Delegations are welcome to deliver brief general statements. Interested delegations should contact the Implementation Support Unit to be inscribed in the speakers' list.

# 9 Informal presentation of requests submitted under Article 5 and of analyses of these requests

The 13MSP will need to consider requests for extensions on mine clearance deadlines that have been or will be submitted by Chad, Mozambique, Niger, Serbia, Sudan and Turkey. In keeping with the practices successfully employed since 2008, there will be an opportunity for informal presentations of and discussions on extension requests with the States Parties returning to formal consideration of these requests later in the week.

# 10 Reflecting on how to enhance international cooperation and assistance and to increase resource mobilization

In presenting his initial ideas for the 13MSP in May, the President-Designate recalled that the Second Review Conference attached great importance to the matter of international cooperation and assistance and that the 13MSP is the last formal meeting to take stock of collective efforts on this and other matters before the Third Review Conference. The President-Designate therefore proposed that relatively greater time be given to a more in-depth discussion on key topics concerning international cooperation and assistance. This will be done through Agenda Item #10 when two interactive panel discussions will take place to reflect on how to enhance international cooperation and assistance to ensure and mobilise sufficient resources, through international partnership bringing in all relevant stakeholders in support of the establishment and development of national min-action capacities of affected States.

#### a Interactive panel: Assessing to the Convention's cooperation and assistance machinery

Since the 2009 Cartagena Summit on a Mine-Free World, the States Parties have held an informal session on cooperation and assistance, established a Standing Committee, continued to place cooperation and assistance on the agenda of formal meetings, and established the platform for partnerships information mechanism. The purpose of this session is to engage in discussion regarding how these different mechanisms are working to facilitate cooperation and assistance. Discussion will be initiated by panellists sharing different perspectives on this matter. To prepare for this discussion delegations may wish to consider the following questions:

- Is the manner in which cooperation and assistance is dealt with in formal and informal meetings serving a useful purpose in enhancing implementation efforts?
- Is the Standing Committee on Resources, Cooperation and Assistance meeting expectations that delegations had for it when it was established? How can this mechanism best be used?
- What kind of information related to cooperation and assistance do different delegations value and why? Is the platform for partnerships a useful way of sharing this information or is there a need for complimentary measures, such as amendments to the reporting format?

#### **b** Interactive panels: Partnerships for implementation

At the Cartagena Summit, States parties recognized the need for partnerships to achieve the aims of the Convention which, even then, was recognized more important than ever. These interactive panel discussions aim to discuss the need for international partnerships including:

(i) Successful Article 5 completion can be fuelled by solid partnerships which feature strong national ownership by affected States Parties, a lasting commitment on the part of those in a position to assist, and an intermediary or capacity-building entity. The purpose of this session is to draw lessons from various experiences of bilateral and international cooperation partnerships pertaining to completion. To prepare for this discussion delegations may wish to consider the following questions:

- How can mine-affected States enhance national ownership and thus in facilitating efforts to form partnerships for completion?
- What do mine-affected States believe are the greatest barriers to overcome to deepen partnerships for completion?
- How can partnerships at the international level best support Article 5 completion?

(ii) The Convention's promise to landmine survivors will be, in large part, achieved through the integration of activities into broader approaches, particularly broader approaches disability. The purpose of this session is to explore how partnerships between the landmines world and the larger world could assist the States Parties in enhancing cooperation and assistance to achieve our victim assistance aims. To prepare for this discussion delegations may wish to consider the following questions:

- How can States Parties make use of the full range of funding sources for victim assistance, be they specifically related to mine action or not?
- How can States Parties ensure that funds that are invested are actually achieving their desired ends?

States Parties which have recently completed or are still in the process of clearing mined areas are invited to provide brief updates on their efforts to fulfil their obligations. These updates should contain only new information with efforts made to avoid duplication with respect to updates provided in May. Other delegations are welcome to remark on these updates and to share their views on mine clearance.

#### 11c Consideration of the general status and operation of the Convention: Destroying stockpiled anti-personnel mines

States Parties responsible for destroying stockpiled anti-personnel mines (including previously unknown stockpiles) are invited to provide brief updates on their efforts to fulfil their obligations. These updates should contain only new information with efforts made to avoid duplication with respect to updates provided in May. Other delegations are welcome to remark on these updates and to share their views on stockpile destruction.

#### 11d Consideration of the general status and operation of the Convention: Universalizing the Convention

States not party to the Convention are invited to share views on the Convention and to provide updates on steps that are being taken or considered to accede to the Convention. Other delegations are invited to provide updates on their efforts to encourage universal acceptance of the Convention and to share their views on universalization.

#### 11e Consideration of the general status and operation of the Convention: Implementation support

Further to the "Directive from the States Parties to the ISU" adopted by the 10MSP which instructs the ISU to propose and present a work plan and budget for the activities of the ISU for the following year to the Coordinating Committee for endorsement and subsequently to MSPs for approval, the 13MSP will be asked to approve the work plan and budget for the activities of the ISU in 2013.

In addition, further to the "Directive from the States Parties to the ISU" which tasks the ISU to report in written form as well as orally on the activities, functioning and finances of the ISU to each MSP, and, to submit an audited annual financial report for the previous year and a preliminary annual financial report for the present year to the Coordinating Committee and subsequently to MSPs for approval, the 13MSP will be asked to approve the report on the activities and finances of the ISU and the ISU's 2012 audited financial statement.

The 13MSP will be asked to agree that intersessional work in 2014 take place the afternoon of 9 April, that a second preparatory meeting in advance of the

Third Review Conference take place all day on 10 April, and that additional intersessional work could take place on 11 April subject to the Coordinating Committee considering what, if any, additional intersessional work may be required given the short period of time between the 13MSP and the Third Review Conference.

(Note that in May the 12MSP President proposed that Belgium preside over the 14MSP, without prejudice to when the 14MSP may take place.)

In keeping with established tradition, the Co-Chairs of the Standing Committee on the General Status and Operation of the Convention (Bulgaria and New Zealand) undertook the task in 2013 of consulting with States Parties to identify a list of nominees to serve as new Co-Chairs following the 13MSP. On 11 March, the Co-Chairs wrote to all States Parties to indicate that they were seeking one new State Party for each of the five Standing Committees for two-year terms. At the 27 May meeting of the Standing Committee on the General Status and Operation of the Convention, the Co-Chairs again reminded delegations of their written appeal. On 19 September, the President-Designate indicated that, based upon interest expressed, Bulgaria and New Zealand are proposing that the following States Parties serve as Co-Chairs from the end of the 13MSP for a two-year term:

- · General Status and Operation of the Convention: Belgium
- Victim Assistance: Costa Rica
- Mine Clearance: Japan
- Resources, Cooperation and Assistance: Indonesia
- Stockpile Destruction: Poland

If this proposal is agreed to by the 13MSP, the above mentioned States Parties would join the following, which would be completing the second year of their two year terms between the end of the 13MSP and the end of the Third Review Conference:

- Status and Operation of the Convention: New Zealand
- Victim Assistance: Austria
- Mine Clearance: Mozambique
- Resources, Cooperation and Assistance: Ecuador
- Stockpile Destruction: Norway

Note: In carrying out their consultations, Bulgaria and New Zealand indicated that the selection of Co-Chairs at the 13MSP no doubt would be without prejudice to decisions the Third Review Conference in 2014 may wish to take with respect to the Convention's committee structure or its meeting programme.

The European Commission always supports efforts towards a mine-free world within a broader context of humanitarian assistance as well as long-term and sustainable socio-economic development programs. The EC recently decided to fund two large projects including about 50 European organizations, NGOs, universities, small and medium sized enterprises and industrial partners. The Royal Military Academy of Belgium coordinates one these projects, TIRAMISU, which aims at providing the foundation for a global and comprehensive toolbox that will cover the main mine action activities, from the survey of large areas to the actual disposal of explosive hazards, including mine risk education, training and management tools.
